#### **Scope**

1. ### **Confidential Information and Non-Competition**

8. For a period of five years following end of validity of the agreement or Termination of this MOU for any reason whatsoever, The party to the second part agrees that it will not , Either individually or in partnership or in conjugation with any person, firm,

association, company or corporation as principal, agent, director, officer, employee, or in any other manner whatsoever, sell directly or indirectly, in part or full any products as mentioned in Clause 1 herein of Pulse Global Services, to any person, or firm or corporation at any time during the five years after the termination or validity of this MOU.

9. Termination:

1) In the event that The Retainer fails to carry out its services stated herein above, The Client may terminate this MOU at any time after giving 15 days written notice to The Retainer. This MOU shall be immediately terminated by notice if either party fails or refuses to perform or observe or comply with any of its obligations or conditions under this MOU.
